<u>20-03-2024</u>

Resolution to oppose an Energy from Waste facility in the Pontiac MRC

WHEREAS: MRC Pontiac Council of Mayors is considering the establishment of a 400,000 ton garbage incinerator that would rely on bringing in 395,000 tons of waste annually from surrounding municipalities and the city of Ottawa.

WHEREAS: MRC Pontiac Council of Mayors may be considering going forward with another, more costly business plan on the project.

WHEREAS: Garbage incinerators are costly to build and costly to maintain.

WHEREAS: Garbage incinerators are known to emit toxins, such as dioxins and furans, that are extremely dangerous for human health, farm produce, and livestock, and they are not a source of clean energy.

WHEREAS: Garbage incinerators produce bottom ash which is laced with toxic residues and fly ash which is heavily contaminated. It is estimated that burning 400,000 tons of garbage each year would result in approximately 100,000 tons of ash to send to landfill – 20X what MRC Pontiac currently sends to landfill.

WHEREAS: Garbage incinerators are not good at creating jobs. Far more jobs are created by using alternative waste management strategies.

WHEREAS: MRC Pontiac's current total annual household waste of 5,000 tons can be reduced by a waste management strategy that includes, reduce, re-use, recycle, and increasing composting which would be far less costly and far less dangerous to the environment and human health.

THAT the Municipality of Otter Lake will not support going forward with a garbage incinerator nor will it support the development of another business plan for this proposal.
